- ◆ Open to all artists 16 years of age or older residing in Bladen, Brunswick, Columbus, New Hanover, Pender, Robeson Counties.
- ◆ All art submitted must be original works and executed within the past two years, not previously exhibited with CCAC. Works requiring special installation will not be accepted.
- ◆ A non-refundable entry fee for a limit of two pieces, along with completed entry form must be presented at delivery of work.
- ◆ Art work may not exceed 65 inches in any direction, including frame. **ALL 2-D work must be ready to hang in frames with strong eye screws and wire. Art work with saw tooth hooks or glass and clips WILL NOT BE ACCEPTED!**
- ◆ It is strongly encouraged that the works be listed for sale during the exhibit. CCAC will retain 30% commission on any artwork sold.
- ◆ All works must remain on display until the close of the exhibit. Works must be picked up at the designated times. **Work not picked up during the designated pick-up time becomes the property of CCAC .**

DELIVERY OF ART

Art must be hand delivered to the Arts Council according to the following schedule: **November 11,12, 2024 - 9:00AM-1:00PM** or by appointment.

RECEPTION

The Arts Council will host a reception on **FRIDAY, November 15, 2024 - 7pm-8:30pm** and is open to the public.

EXHIBIT TIMES

The Columbus County Arts Council’s hours are **9:00AM-1:00PM Tues.—Thur.** or by appointment. This exhibit will remain on display **Nov. 15, 2024-Jan. 7, 2025.**

All work must remain on display until January 7, 2025. All work must be picked up on Thursday, January 9, 2023 between the hours of **9:00AM-1:00PM** or by appointment.
